

ARTICLES OF INCORPORATION
OF
SOUTHWESTERN HERITAGE CENTER HISTORICAL SOCIETY

A Nonprofit Corporation

ARTICLE I.

The name of the Nonprofit Corporation is Southwestern Heritage Center Historical Society.

ARTICLE II.

The purpose of the nonprofit Corporation is to discover and memorialize the history of Southwestern Utah; to discovery, purchase, commission, or otherwise procure, and to publish or otherwise preserve writings, newspapers, journals, and the like, which shed light on the history of the region; to discovery, procure, and preserve physical objects that may relate to the history of the region; to establish and maintain museum on land leased or owned by the society; and to hold regular meetings and other activities for the recreation and instruction of the members.

ARTICLE III.

The Registered Agent of the Nonprofit Corporation is Alva Matheson, whose street address is 8847 West 2200 South, Cedar City, UT 84720.

ARTICLE IV.

The name of the Incorporator is Alva Matheson, whose address is 8847 West 2200 South, Cedar City, UT 84720.

ARTICLE V.

The Nonprofit Corporation will have voting members.

ARTICLE VI.

The Nonprofit Corporation will not issue shares of stock evidencing membership or interests in water or other property rights.


ARTICLE VII.
