Collision of Freight Cars Kills Three and Injures Two.

David Bulloch of Cedar in Critical Condition-Wreck Occurred Near Beryl Sunday Morning.

Latest advices from Salt Lake are to the effect that David Bulloch is slowly ralliyng from his injuries and is now practically out of danger. It is welcome news to his many friends in southern Utah.

A most disastrous wreck occurred on the San Pedro, Los Angeles and Salt Lake Railway last Sunday morning at 5:30, which resoluted in the death of three men and serious injury of two others, one of the latter being David Bulloch of Cedar City.

The dead are:

Conductor G. W. Myres of Black Rock, Utah.

Extra Brakman W. T. Engles, Black Rock.

Brakeman W. F. Setphens, Black

The latter died as a result of his injuries while en route to Salt Lake.

THE INJURED.

The injured are David Bulloch of Cedar City, who is lying in the Holy Cross hospital at Salt Lake in a critical condition, and E. Huginni, a jeweler of Salt Lake City, who though severely bruised is not seriously injured.

HOW WRECK OCCURRED. The wreck was due to the first

section of the regular freight train, known as No. 81, breaking in two when one and one-half miles east of Beryl, and leaving nine cars on the track, which were crashed into by the second section of the train, there being a heavy fog a the time. Mr. Bulloch was acompanying a

on a special train and dispatched to Salt Lake City, while the authorities of Iron county were notified and County Attorney Ryan and Precinct Justice Herbert C. Adams of Cedar City at once repaired to the scene to hold inquest over the dead men. FAMILY ADVISED.

DISASTROUS WRECK sidreable fortune in the raising of cattle and sheep. He carried considerable life insurance, and should the worst happen he would leave his family in comfortable circumstances. During the construction of the Salt Lake Route, on which he received his injuries, he had the contract of supplying the camps with beef, and made frequent shipments over the road. When the road was completed he made a contract to furnish some of the Nevada mining camps with steers and he was accompanying one of these shipments at the time of the accident.

> Mr. Bulloch is a pioneer of Iron county, and was one of the two representatives who accepted of the hospitality extended by Senator Clark to the pioneers last summer. He has eight children living in Cedar City.
