**Present Official List of Persons
who Will Fill Iron County's
Quota in Draft.**

**30 PER CENT TO REPORT
EACH FIFTEEN DAYS**

**All Fathers Married Before Conscrip-
tion Law was Passed Excused
by Exemption Board.**

Pres. L. N. Marsden of Parowan, who is a member of the county exemption board, was in Cedar City again yesterday on business connected with the filling of Iron county's quota of the draft. The board takes the stand, in the light of recent rulings, that all fathers, married before the passage of the law calling the draft, should be exempted. This, with the failure of a great many to come up to the physical requirements, has necessitated the calling of a great many more men than had been anticipated, to fill the required quota.
